Vision 2020: Through the eyes of a child

The conference will examine a range of topics including: new approaches to family justice and child issues; the exploitation of children; protecting especially vulnerable children; changing family formations; international families; social media and children; adoption, surrogacy, parentage; a diagnosis and possible interventions for troubled families; financial rights, including property, offshore assets, cryptocurrencies, as well as international, social and cultural considerations.

In addition, in a world of highly mobile families, the conference will give attention to the ways in which family law meets the various needs of families in whatever form, in order to provide a structure which can effectively and justly provide for its members who are the subject of relationship breakdown.

The primary aim of the conference is to develop outcomes that directly benefit those who are especially vulnerable and disadvantaged.

Our Vision

Our hope is that the 8th Family Law & Children's Rights Conference, in July 2020, will be able to set examples by promoting international co-operation on the movement of children, best practices to address family violence and observations of our international treaties and to revisit cyber safety and human trafficking.

Our legacy for the Singapore conference will be to identify those resolutions that challenge and import systemic change and ensure that we provide funding to those causes to secure that change. Funds provided by sponsors will be utilised to support the ongoing work inspired by the presenters and arising out of the themes.






